UNIVERSITY OF TORONTO ARCHIVES

MISSION

The University of Toronto Archives is dedicated to acquiring, preserving and making available the documentary heritage of the University of Toronto as a permanent resource in support of operational, educational, and research needs of the University community and the general public. While promoting the fullest access to information we are bound to protect the privacy of individuals and corporate bodies entrusting their records to our care and to maintain the highest possible standards of professionalism and archival practice.

MANDATE

The University of Toronto Archives is responsible for the appraisal, acquisition, preservation and use of University records of permanent value and the private records of individuals and organizations associated with the University. The University Archives works co-operatively with other permanent campus archives programmes devoted to preserving their sponsor's documentary heritage. As well as providing a research service, the University Archives provides an administrative service through the development and implementation of the University's records management programme. The objectives of this programme are detailed in the Terms of Reference of the Presidential Advisory Committee on Archives and Records Management.

1. INTRODUCTION

The events of the past year emphasised how vulnerable the University Archives is to fiscal and organisational changes within the Library. Annual collection growth continued at an average rate of 400 cu. ft. Unfortunately, the preservation of these materials and existing holdings was jeopardised by the termination of funding for traditional reformatting technologies such as microfilming and wet photography by the Library. Thus, we were required to seek funding from external sources.

Available storage space also reached critical levels by the end of the year and challenged our ability to provide timely access and to preserve both university and private archival records. Without an increase in suitable onsite storage, greater funding will be required to store materials at a commercial offsite storage facility.

Budget cuts also affected staff levels at the Archives, although the full impact of this 14% decrease in FTE complement will not be realized until 1997-1998. Ongoing operations continued to suffer with the limitations of outdated computer technology. As with preservation, the Archives sought external Library funding for this essential operating equipment. The debilitating effects of this situation were off set, in part, by the expert support provided by the Library's Systems staff in the development of our web site.


Our administrative responsibilities in support of records management expanded with the development of sections on financial and employment records in the <u>University File Plan</u>. The management of active records was discussed in more detail in a comprehensive long-term plan submitted to the Presidential Advisory Committee on Archives and Records Management. The six objectives of this plan provide a framework for records management initiatives over the next five years. With sufficient financial resources, a full records management programme could be in place throughout the University by 2002.

In spite of these challenges, Archives' staff made significant accomplishments in major areas relating to collections development, donor relations, and research and reference services, the details of which will be found in the following pages. Their continuing diligence, professionalism and patience during the past year are the main reasons for this success.

2. ACQUISITIONS

2.1 Collection Growth

The volume of acquisitions returned to more normal levels during this reporting period as shown below. A total of 65 accessions were confirmed from both university and private sources. This represents an extent of 143.36 metres (470 linear feet), a decrease of 119% from last year's unusual high of 313 metres. The additional volume of 7.45 metres of library materials received is comparable to previous years.



Unlike last year, the extent of private records accessions received during the year exceeded accessions received from university offices. As shown above, this pattern is common over four of the past five years. Textual, paper-based accessions continue to be the predominate medium of our acquisitions. Photographic materials (prints, negatives, slides), followed by sound and moving image records made up the next two major types of media received during the past year.

2.2 A Accessions (University Records)

During the past year, university offices transferred 58 metres (190 linear feet) of permanent value records to the Archives. Additional transfers were received from the Office of the Dean, Faculty of Medicine (23 metres), the Department of Public Affairs (3.20 metres) and the Department of Psychiatry (.27 metres). As a result of reorganization within the University, the Archives received 22 metres of records from the former Office of the Vice-president (Business Affairs). These records document predominantly the administrations of vice-presidents Alex Pathy, R.L. Criddle and B.P. Davies from 1981 to 1993, and complement other holdings in the Archives relating to financial administration of the University. New acquisitions included records from the Audio-visual Library (1970-1996; 2.40 metres), the Office of the Campus Library Co-ordinator (1974-1996; 1.60 metres) and the Status of Women Office (1974-1993; 2.40 metres). 2.3 B Accessions (Private Records)

In the area of private records, the University Archives has continued to add to *fonds* already in the Archives, and to acquire records in areas not previously documented. In the former category, significant additions have been made to the personal records of professors E. K. Brown (english), Bernhard Cinader (immunology), Ian M. Drummond (political science), the Fraser Family (medicine), Keith A. McLeod (education), Thomas Howarth (architecture), and Edward Safarian (economics).

New acquisitions include the records of the Ham Family (including James Ham, president of the University, 1978-1982 and, before that, Dean of the Faculty of Applied Science and Engineering), John Black Aird (Chancellor, 1986-1991), C. Claude Brodeur (education), the McPhedran/Duncan/ Green Family (including Harris McPhedran, an associate professor in the Faculty of Medicine, and his second wife, Marie, an award-winning author of books for children), Vera Peters (medicine), Ezra Schabas (music), and Joan Winearls (map librarian).

In addition to the personal records of administrative staff and professors, the University Archives seeks to document the activities of students and student societies and clubs. Here, additions have been made to the personal records of two generations of the Clark Family (law, arts, education, and engineering) and to the records of Camp 1 of the Office of Camp Wardens, Ritual of the Calling of the Engineer. New acquisitions include: Gary Pieter's records of his involvement with the West Indian Students' Association; the course notes of Stefan Saganski, a student in mechanical engineering in the 1950s; Catherine Scroggie's files documenting the reunions of the class of 2T4, University College; and the records of the University of Toronto Medical Society and the Nursing Undergraduate Society. See Appendix B for a complete listing.

2.4 Special Media Records (Table 1)1

As with other acquisitions, the volume of special media records declined to average levels during 1996-1997. The Department of Public Affairs transferred films, slides and audiotapes documenting the fund raising drives at the University between 1966 and 1976. Prof. Ezra Schabas' personal records comprise many videotapes, sound recordings and photographs documenting mainly the Musical Performance and Communication Programme offered by the Faculty of Music from 1971-1991. A small collection of lantern slides from the Omand Solandt estate documents the Atomic bomb damage suffered by Japan during World War II as well as hypothetical A-bomb damage to the Toronto area.

2.5 Donations for monetary evaluation (Gifts-in-kind)

The donation of 14 accessions of private records for the 1996 tax year represented a monetary value of \$50,150. A complete list will be found in Appendix C.

3. RECORDS MANAGEMENT

3.1 Presidential Advisory Committee on Archives and Records Management (PACARM) During the year the Committee held three meetings to discuss records storage, University File Plan, automated systems development, employment records, training, and long term planning. Mark Britt, Director, Internal Audit, replaced Neil Hunter and Lynn Snowden replaced Alvan Bregman as the representative from the Provost's Office on this Committee.

3.2 Financial Records Project / University of Toronto File Plan

Four additional training sessions on the financial records section of the File Plan were held in July for 86 administrative officers. Participants during this series of workshops identified the need for some modifications and additions to this section of the File Plan. These were made by the Records Archivist, Jan Liebaers, and distributed via the Administrative Management System (AMS) Homepage. In the fall, business officers were asked to complete a survey on the application of the <u>University File Plan</u> in general, and the financial records section in particular. This survey was distributed via the AMS listserv in December 1996. The response rate of 10% must be understood within the context of identified Financial Information System (FIS) users since these were the individuals targeted for training and implementation of the File Plan. In the conclusion of his report to the PACARM, Jan Liebaers stated that "one in three offices are using the <u>Plan</u> for filing and managing the life cycle of their financial records. By the end of 1997-1998,... another one third of offices is expecting to implement the <u>Plan</u>".

Jan Liebaers also completed a draft of the Human Resources section of the File Plan. This section is expected to be revised as a result of consultation with Human Resource personnel before implementation, expected in the fall of 1997.

² Approximately 400 business officers attended the training sessions held in April and July 1996. Thus the receipt of approximately 100 completed surveys represents a higher response rate.

3.3 Employment Records Policy Subcommittee

This subcommittee, consisting of Garron Wells (Chair), Jan Liebaers, Janice Draper, Mary Ann Ross and Marie Branker, completed "Regulations on Employment Records". This document provides guidelines for University administrators relating to the collection, use, disclosure and disposal of personal information on employees and lists common types of information. Following approval of the PACARM and the FOI Commissioner, J. Dimond, the document was forwarded to Michael Finlayson, Vice-president, Administration and Human Resources.

3.4 Records Management Manual

Requests for complete copies of the Manual were received from 15 university offices. The majority of these requests were the result of organizational changes within the University over the past year. No revisions to the Manual were undertaken during the year.

3.5 Records Management Long Term Plan

The University Archives submitted a five-year plan for records management to the PACARM in February. The goal of this plan is an effective and responsive records management programme that meets the needs of a rapidly changing administrative environment. Six objectives are identified:

- 1. to compile and maintain an accurate list of all records series created, used, distributed and maintained by University offices
- 2. to develop and maintain retention and disposition schedules for all University records based data collected in the records inventory
- 3. to plan and implement a University-wide vital records protection programme
- 4. to develop and implement effective University-wide standards for records creation and active records control and to distribute these either in paper or electronic format

- 5. to promote efficient, cost-effective control, storage and disposal of semi-active and inactive University Records
- 6. to promote the use of micrographic and electronic image management

Implementation of the full plan required total funding of \$339,000. Only \$120,000 (plus unspecified Library funding) was requested by the Chair to fund the first three years of the programme. Since this funding was considerably less than required, the Archives will review the objectives to identify what actions can be accomplished.

3.6 Training

The "Introduction to Records Management" seminar offered through Employment Training and Development was not held because of insufficient enrolment.

4. ARRANGEMENT AND DESCRIPTION

4.1 University (A Accessions) and Private Records (B Accessions) (Table 2)

The majority of University records accessions received during this period were accompanied by container listings as required under UTA transfer procedures. Extensive work was undertaken, however, by Lagring Ulanday, Records Archivist, on the records of the Audio-visual Library. After final selection and consultation with the office of origin these were arranged and described. Backlog work relating to University records concentrated on the word processing of handwritten finding aids. Barbara Edwards-Asubonteng and Judy Mars were largely responsible for the word processing of 42 finding aids relating to A Accessions. The production of an electronic copy of these finding aids will allow for faster updating when records are processed, and for reformatting onto our Homepage (See Section 5.3).

Harold Averill and Marnee Gamble were responsible for arranging and describing the majority of private records accessions requiring monetary evaluation for the 1996 tax year. These private records accessions included McPhedran/Duncan/Green Family, James Prentice, Ezra Schabas, Grace Scott, Robin Harris and Joan Winerals. Harold Averill supervised a Faculty of Information Studies practicum student, Kim Murray, as she arranged and described the John Satterly personal records as a course requirement.

4.2 Accessions Update Project

Archivists Harold Averill, Lagring Ulanday, Marnee Gamble, Jan Liebaers and Garron Wells proceeded with the second stage of this project, that is, the updating of accessions information for private records (B Accessions) on the Accessions Description database. By the end of this reporting period approximately 50% of the 1269 database records had been updated. It is expected that this work will be completed by the end of December, 1997.

4.3 Special Media

4.3.1 Appraisal of A96-0008 Media Centre records

In the fall of 1996, Marnee Gamble, Special Media Archivist, began work on the appraisal of the approximately 3,000 video recordings received in the last quarter of 1995-1996. An appraisal criteria and time lines for this lengthy project were developed. A database was created to organize the tapes by title and to document the appraisal process. Most of the Special Media Archivist's time was spent collecting information on each title and inputting it into this appraisal database. It is hoped that over the next year, the selection of titles to be retained will be completed.

4.3.2 Graphic Records Database

Accession level descriptions of graphic records for 1995 and 1996 were added to the database. Unfortunately, due to time constraints presented by the A96-0008 appraisal project, the Special Media Archivist was unable to complete descriptions for accessions received in 1986 and 1987.

4.4 M Accessions Project

In 1996-97, a project to dismantle the old M Accessions system and reintegrate the monographs with the rest of the published materials in the Print Room was undertaken. The process is a lengthy one since many need cataloguing or deaccessioning. The M Accessions system was originally established as a control system for published books acquired by the Archives. Often these books on various topics relating to the University's history had already been catalogued by the Library's Technical Services Department, and assigned a Library of Congress classification number before transfer to the Archives. The imposition of another control system by the Archives resulted in unnecessary duplicate labour.

During the year, Demetra Kandelapas, Assistant Library Technician (ALT) reviewed 4.5 metres of books in this system. About 50% of the books were deaccessioned and the remaining were added to the Print Room in LC call number order. This work will continue throughout the following year under the direction of the Special Media Archivist.

4.5 Theses cataloguing

Barbara Edwards-Asubonteng continued with the long term project of entering cataloguing data for theses (T Accessions) on the Library's Marion database. During the year at total of 893 new catalogue records describing Master of Arts theses completed at the University from 1935 to 1946 became available to researchers using UTCAT. A total of 1721 new records have now been added to the on-line cataloguing system since the project began in 1995-1996.

4.6 Guide to Holdings in the University Archives

The development of the UTA Homepage (See Section 5.4 below) provided the Archives with a new approach to publishing a description of its holdings to a wider research audience. Unlike the Library, the University Archives has never produced a catalogue of its archival holdings online for public access. During the spring of 1997, Garron Wells, in consultation with Marc

Lalonde of the Library's Information Technology Services Department (ITS), developed a pilot project for *Fonds* and Accession Level Description of university and private archival records. The objective is to provide researchers with searchable access to descriptions of the various *fonds* (i.e. groups or collections) of both university and private records and to individual accession level descriptions comprising a particular *fonds*. Linkages will also be provided to the Library's on-line catalogue UTCAT. By the end of this reporting period data for five *fonds* and their related accessions were forwarded in ASCII files to Marc Lalonde to develop search engines and mount the data on the UTA homepage.

Once this work is completed, the archivists will proceed with the development of in-house descriptive standards and selection of additional *fonds* and related accessions. Ultimately, the Archives will have a complete catalogue of archival materials – textual, graphic, sound and moving image, architectural, cartographic – published on our web site.

5. REFERENCE SERVICES

5.1 Research Services (Table 3)

Reference service in the Reading Room returned to average levels in fiscal 1996-1997, with 343 new readers and a total of 847 users. The following table compares the past year's activity with the previous four years. (See also Figures 1 to 4)



This pattern of activity was also evident in the number of phone and written enquiries as well as interlibrary loans (ILL). (See Figures 5 and 6). Phone, written and ILL enquiries from members of the university community and the general public declined an average of 13% over 1995-1996. However, this decline is well within average activity levels for the past five years.











5.2 Exhibitions, Tours and Seminars

5.2.1 Exhibitions

Harold Averill, Assistant University Archivist, assisted in the preparation of a very successful exhibition. "The Stuff Dreams are Made Of: The Art and Design of Frederick and Louise Coates" was held in the Thomas Fisher Rare Book Library during the first three months of 1997. The Coates were actively involved in the arts and crafts movement of the early 20th century. Fred was also, at various times, an instructor in modelling in the Department/School of Architecture and Art Director of Hart House Theatre. Curated by Paul Makovsky, the exhibition drew heavily on the personal records of the Coates Family in the University Archives. The exhibition has also identified potential donations to the University Archives of

additional material produced by the Coates from individuals who loaned material for the exhibition.

For our open house held on U of T Day in October, the University Archives staff mounted an exhibition that illustrated the varied nature of materials housed in the University Archives. Harold Averill and Marnee Gamble selected and displayed original archival materials in all media, which demonstrated both the variety of types of archival documents as well as the long and diverse history of the University. A total of 31 people viewed the display in the Reading Room of the Archives.

5.2.2 Tours/Seminars

During the year, the staff of the Archives conducted a number of tours and presentations. Harold Averill conducted a tour for City of Scarborough officials (relating to the Coates exhibition mounted in January, 1997) in August, 1996. In October, he and Marnee Gamble provided a tour and commentary for eleven students from the Faculty of Information Studies, and in November, Harold conducted a seminar on archival resources in the Archives for thirteen Faculty of Social Work students. During the summer, Garron Wells presented a seminar and tour on university archives to 22 students enrolled in the Special Archives course in the Faculty of Information Studies.

5.3 UTA Homepage

In February, the Archives launched its web site developed with the assistance of students in the Faculty of Information Studies, and ITS. All Archives staff contributed to the content and layout of the text and graphic images which provided general information on Archives' services and hours of operation, scope of holdings, notices of new acquisitions, staff contacts and links to other University and external homepages. Barbara Edwards-Asubonteng prepared the word processed text, scanned selected graphic images, converted all information to HTML, and worked with staff at ITS to complete the design and editing. The homepage is accessible

through the University of Toronto homepage or via its URL address: http://utl1.library.utoronto.ca/www/archives/index.htm.

6. CONSERVATION

6.1 Photographic Preservation Project - A65-0004

The duplication of glass plate negatives in A65-0004, which began in July 1995, was completed by September 1996 with all copy negatives being stored in hanging sleeves in filing cabinets. The original conservation project was to include refoldering and reboxing of glass plate negatives but due to a shortage of time and staff this part of the project was not undertaken. Instead, some time was spent reorganizing two series of contact prints so that the images will be easily accessible. Demetra Kandelapas, under the supervision of the Special Media Archivist, spent the winter sorting, labelling and reboxing the contact prints from the portrait series (135 series) into an alphabetical arrangement. During the next fiscal year, a similar rearrangement of the group series will be undertaken.

6.2 Preservation Strategic Plan

With the termination of microfilming and photographic services by the Library in the summer of 1996, a new strategy was required to ensure the preservation of the University's documentary heritage. In the spring, Garron Wells, with the input of Archives staff, prepared a preliminary plan outlining three strategies: reformatting, holdings maintenance and conservation. The trend in libraries toward the adoption of electronic imaging in place of microfilming is preferred to improve access to published materials. The reformatting of original archival records involves compliance with statutory requirements, as well as the need for permanent preservation. Thus the University Archives must have a preservation plan that utilizes both new and traditional technologies to ensure that operational and research needs are met. The Preservation Plan, with accompanying project proposals and costs, was submitted to the PACARM for approval. The Committee agreed to recommend funding for a portion of the reformatting costs for University records. The Chair made a submission of \$30,000 over the next two years to the University's Budget Planning Secretariat. Further discussion on long term funding for preservation of all Archives holdings will be undertaken by the PACARM in fiscal 1997-1998.

6.3 Storage space

The UTA exhausted its available onsite storage space in all locations during the year. A survey of shelving space in the summer of 1996 revealed that the UTA had less than 5% of our total capacity remaining. As a result, the Archives shipped a total of 202 boxes containing theses and university records to offsite storage. By the end of fiscal 1996-1997, the UTA had a total of 458 linear feet of records stored with the University's preferred vendor (Pierce-Leahy). Some space saving was achieved through the destruction of the remaining student records and other University records covered under records retention schedules. Annual funding from the Library resulted in the destruction of approximately 300 cu. ft. of university records and culls from private records accessions.

The need for additional onsite storage facilities has become critical for both the UTA and the Library in the past year. Recognizing this development, the Library initiated a Task Force on Long Term Space Utilization Plan for the Robarts Library Building. While its initial objective was to arrange for the storage of the undergraduate collection housed at Sigmund Samuel Library building, it is expected that this Task Force will be reviewing the B1 level of Robarts Library where the UTA and the Rare Book department store their collections. It is hoped that a plan for improved storage facilities (such as compact storage) will result. Until this is achieved, the Archives will require ongoing funding to ship annually approximately 350 cu. ft. to offsite storage to allow for the accommodation of new acquisitions.

6.4 Canadian Institute for Historical Microreproductions (CIHM)

The Archives continued to lend material to CIHM for microfilming, specifically post 1900 monographs relating to science. A total of 24 items were lent, mainly from the University of Toronto Studies series. Marnee Gamble co-ordinated the borrowing with a staff person from CIHM.

7. ADMINISTRATION

7.1 Closing projects, August, 1996

The annual closing of the University Archives to the public took place from August 19 to August 30. The main project undertaken during this period was the unpacking, sorting and inventorying of the over 3000 items received from Media Centre (A96-0008). Marnee Gamble, Lagring Ulanday and temporary employee, Aliesa Faherty, were responsible for the completion of this project. Harold Averill and Jan Liebaers completed a report on storage space. Remaining staff moved records in preparation for destruction, accessioned backlog materials and continued work on updating B Accessions information.

7.2 Staffing

The Archives was not immune during the past year to the repercussions of budgetary constraints felt by the Library. As a result, the Clerk-typist position was eliminated and Judy Mars was transferred to the Order Department on a part-time basis in January, 1997, and on a full-time basis on May 1, 1997. The duties of this position relating to retrieval and shelving of accessions used by researchers, photocopying of archival materials for researchers, serials maintenance, and word processing were distributed among remaining staff. The impact of this reduction of 14% of staffing complement will inevitably affect Archives' service to the University community in the coming year.

Marnee Gamble returned from leave in August, 1996. Aliesa Faherty (GALT) and Demetra Kandalepas (ALT) were employed as summer and fall/winter casual staff respectively.

7.3 Professional Activities

Harold Averill, Assistant University Archivist, continued in his position as Secretary to the Board of the Canadian Gay and Lesbian Archives and was editor of the 1997 edition of "Gay and Lesbian Archivist" newsletter. As a result of his involvement with this organization,

Harold was interviewed for the publication <u>Liberating minds</u>: the stories of professional lives of gay, lesbian and bisexual librarians and their advocates, edited by Norman G. Kester (Jefferson, North Carolina: McFarland & Company, 1997). The text of this interview is titled "Queering the historical records: an interview with Harold Averill of the Canadian Gay and Lesbian Archives". Revisions to his chapter for the biography of Daniel Wilson were also undertaken during the year.

Lagring Ulanday, Records Archivist, attended three workshops: "Marketing and Archives", "Arrangement and Description" and "Introduction to management of small archives" presented by the Archives Association of Ontario in 1996. These workshops are part of a series of courses leading to a certificate in archives. She also completed her Bachelor of Arts degree from the University of Toronto in June, 1996. Lagring also continued as archivist for the Association of Records Managers and Administrators (ARMA) Toronto Chapter and attended monthly meetings. She attended two other ARMA functions: "Leadership training" and the International Annual conference in Denver, Colorado. She also represented the Fisher Library area on the Library Council during the past year.

In November, 1996, Jan Liebaers, Records Archivist, attended a seminar on Electronic Records retention scheduling presented by the ARMA Toronto Chapter. In April, 1997 he attended, with Garron Wells, a presentation on the paperless office also presented by ARMA.

Garron Wells, University Archivist, began a two year term as member of the Nominations, Elections and Awards Committee of the Association of Canadian Archivist in 1996. She continued as well to serve as Treasurer of the Canadian Archives Foundation and worked with the authors preparing the manuscript for a revised edition of Ounce of Prevention. In January, she completed all requirements for designation as "Certified Records Manager" by the Institute of Certified Records Managers.

7.4 Automation

In the fall, the installation of the three on-line personal computer workstations received in fiscal 1995-1996 was completed. The use of these machines was shared among the seven FTE and one casual staff member. This event did mark, however, the first time staff was able to experience some of the full potential of on-line technology and became familiar with using e-mail and the Internet on a more regular basis. Unfortunately, no funding was received for the remaining six on-line workstations required to bring the Archives up to University standards. The Archives continues to operate with predominately substandard standalone equipment .
