MISSION

University of Toronto Archives and Records Management Services (UTARMS) is dedicated to acquiring, preserving and making available the documentary heritage of the University of Toronto as a permanent resource in support of operational, educational, and research needs of the University community and the general public. While promoting the fullest access to information we are bound to protect the privacy of individuals and corporate bodies entrusting their records to our care and to maintain the highest possible standards of professionalism and archival practice.

MANDATE

University of Toronto Archives and Records Management Services is responsible for the appraisal, acquisition, preservation and use of University records of permanent value and the private records of individuals and organisations associated with the University. UTARMS works co-operatively with other permanent campus archives programmes devoted to preserving their sponsor's documentary heritage. As well as providing a research service, the department provides an administrative service through the development and implementation of the University's records management programme. The objectives of this programme are detailed in the Terms of Reference of the Presidential Advisory Committee on Archives and Records Management.

1. INTRODUCTION

This report covers two years: May 1, 2007 to April 30, 2009 ¹, a period that was marked by remarkable collection growth and corresponding challenges for Archives staff. The report is divided into sections relating to our primary functions, viz., acquisition, arrangement and description, reference services, facilities and administration.

Overall our total volume of holdings increased by 30% adding some 465 metres (1525 feet). Our total holdings are now more than 9,200 metres (30,479 feet). With no increase in staffing levels, the challenge for existing staff has been to manage this increasing volume and complexity of our holdings while still meeting our commitments to researchers and donors. Of particular note is the growth in volume of individual gifts-in-kind which require processing in preparation for monetary evaluation and the issuing of tax receipts. During these two years we have met most of these commitments, but a backlog is developing simply because the work exceeds our resources. Donors will be waiting longer for their tax receipts in the years to come.

Permanent value university records continue to be transferred at a steadily increasing rate. Ongoing records management training provided by UTARMS has served to facilitate better management of current records and promote the scheduling and transfer of inactive records in University offices. Compliance with provincial privacy legislation has added to this department's workload resulting in the need for accurate and detailed finding aids to ensure no breaches of privacy occur and to facilitate the release of information in a timely manner to researchers and university administrators. Work was undertaken on some of the backlog of holdings but this is a long term endeavour given our limited resources.

Collections are now spread over two onsite and two off site storage areas which presents ongoing challenges for management and preservation. University records acquisitions are now routinely sent to off site storage to make way for incoming gifts-in-kind from private donors. Acquisitions of special media from both university and private sources have necessitated further adjustments to storage areas to provide appropriate accommodation. A separate report recommending a strategy for the use and preservation of moving image records, a fragile medium which requires not only stable storage conditions, but also digital migration to prevent technological obsolescence.

UTARMS is fortunate to have a stable complement of experienced, professional staff, along with an everchanging resource of two part-time student assistants. This team has met the challenges of the past two years to the best of their abilities and both researchers and donors continue to laud their performance and service.

2. ACQUISITIONS

2.1 Collection Growth²

The past two years have continued a trend of significant collection growth begun in 2006-2007. Since May 1, 2007 more than 465 metres (1525 feet) of permanent value records in all media have been added to our holdings. This brings our total holdings to 9290 metres (30,479 feet) at the end of 2008-2009. A break down of this growth is as follows (and in the graph below):

2007-2008:

A accessions (University records) = 100 metres (328 feet)

B accessions (Private records)= 86 metres (283 feet);

Other accessions (publications, theses): 2.0 metres

Total of 188 metres (617 feet). This represents a 29% increase over the previous year.

2008-2009:

A (University records) accessions = 153 metres (501 feet);


B Accessions (Private records)= 120 metres (393 feet);

Other accessions (publications, theses) = 4 metres

Total of 277 metres (909 feet), or an increase of 31% over the previous year.

The types of materials received by the Archives during this time period have been far ranging encompassing all forms of media including the traditional paper and photographic forms. In 2008-2009 especially we saw the acquisition of an unprecedented high volume of special media records in the form of video, and film, as well as works of art and other graphic materials. The following sections provide more detail about the specific acquisitions made during the past two years.

2.2 **University Records (A Accessions)**

Over the past two years, 45 accessions were received from University Offices totalling 253 metres (830 feet). Such transfers of records in all media included accruals to existing fonds such as Office of Governing Council (3 accessions for total of 60 metres), Real Estate Operations (50 metres), Ethics Review Office (11 metres) and Department of Psychiatry (11 metres). New fonds included Faculty of Information (11 metres), and The Innovations Group (18 metres).

Acquisitions in 2007-2008 represent an increase of 19% over 2006-2007. In 2008-2009 we surpassed even that level taking in an unprecedented level of 153 metres, a 50% increase over the previous year. See Appendix A for complete listing.

2.3 Private Records (B Accessions)

The total volume received amounted to 206 metres (676 feet) with 86 metres (in 21 accessions) in 2007-2008 and 120 metres (in 31 accessions) during this past year. Overall, we saw our holdings of private records increase by an average 32% over acquisitions in 2006-2007.

Among the 52 gifts received over the past two years were a number of new fonds including former faculty and staff such as J.N Patterson Hume (computer science), James Bruce Falls and Irene Nosyk (zoology), Larry Richards and Frederic Urban (architecture), McCarthy Family (engineering and medicine), Phyllis E. Jones (nursing), Carl Berger (history), William J. Fowler (applied psychology), and G.Peter Richardson (religious studies). Accruals to existing fonds included R. Craig Brown, C.P. Stacey and Robert Bothwell (history), R. Brian Land and Joan Winearls (library science), T.J. Meek (near eastern studies), Marion Wyse (student), Scott Eddie

(economics), Howard F. Andrews (urban geography), James Ham (engineering), David Rayside (Political Science), Ezra Schabas (music) and Martin Friedland (law).

Over the past four years we have seen a growing trend towards larger individual gifts while the number of gifts per year remains fairly constant. In 2005-2006, the average size of a gift was a little over 1 metre. In 2007-2008 it peaked to 10 metres per gift, falling to an average of 4 metres per gift in 2008-2009.

2.4 Special Media Records (Tables 1a and 1b)

The 2007-2008 and 2008-2009 years were dominated by acquisitions of special media mainly from university offices as a result of large scale renovations of a department's space or impending move to a new building. Of special interest was the transfer of 245 architectural drawings from Office of Capital Projects (A2007-0006). (See Section 4.2.4 for more details) The old Zoology Department, through the Department of Cell and Systems Biology, arranged for the transfer of approximately 700 teaching charts (A2007-0019) in the fall of 2007, followed a year later by 5.8 metres of photographs, slides, negatives, sound recordings and videos (A2008-0016). Again in the fall of 2007, the Faculty of Medicine transferred records from the old Instructional Media Services including 2.4 metres of graphic records (A2007-0017) from the photography unit and, in January 2008, 130 boxes of tapes and sound reels as well as 240 cans of film from the media productions unit.(A2008-0003). Other offices contributing to a record extent of special media acquisitions include: Office of the President with 10 metres (30,000 items) of photographs (A2008-0004), Faculty of Physical Education and Health with 2 metres of photographs (A2008-0017), New College with 20 sound recordings (A2007-0018) and Hart House with 1.7 metres of photographs.

Multimedia private acquisitions also added considerably to special media holdings. These records include photographs, slides, negatives, sound recordings, film and video document various disciplines. Some of the more significant collections include Richard Lee (anthropology), Patterson Hume (computer science), and T.J. Meek (Middle Eastern studies)

These years also saw the acquisition of several pieces of artwork through private donations. The staff artist responsible for painting many of the Zoology teaching charts donated 13 of her own personal original works of art. The Archives also received two paintings by Faculty of Architecture professor, William Carswell and a unique gift of 3 oversized holographs was donated by Prof. Michael Page of the Ontario College of Art & Design. These items were produced in collaboration with University of Toronto's Institute of Optical Science.

2.5 Donations for Monetary Evaluation (Gifts-in-kind) 2007 and 2008

Total value of gifts for these two years amounts to \$318,500. The 2008 value, much less than other years, reflects the fact that several large gifts were received late in 2008, and remain unprocessed prior to monetary evaluation. This value is expected to increase once these gifts are evaluated in the next year. The 2006 value below reflects adjustment for 2 gifts evaluated in 2007.

3. RECORDS MANAGEMENT

3.1 Training Sessions

Over the past two years, Loryl MacDonald, Records Archivist, has conducted 15 seminars comprising our 3 core course series for a total of 225 employees. In addition, between May 1 2007 and April 30 2008, Loryl provided three special seminars to 47 staff from VP Research Services (11 attendees), the Ontario Institute for Studies in Education (27 attendees), and Procurement Services (9 attendees). In 2008-2009 Loryl did a special presentation on electronic records for the Office of Continuing Education & Professional Development, Faculty of Medicine (20 people).

3.2. Consultation, inquiries, and other activities

Between May 1 2007 and April 30 2008, 147 written and 61 phone inquiries were received relating to records management practices and procedures. In 45 instances, Loryl made site visits at the request of the office. Among the offices receiving this service were Capital Projects, Governing Council, Hart House, the Faculty of Information, the Innovations Group, Ontario Institute for Studies in Education, Procurement Services, and Undergraduate Medical Education. Activities in this area declined slightly in 2008-2009, with Loryl responding to a total of 156 inquiries. As a result 36 site visits were undertaken at the request of offices. Among the offices visited were the Department of Anthropology, the Faculty of Architecture, the Department of Chemical Engineering, the Division of University Advancement, Environmental Health and Safety, the Department of Laboratory Medicine and Pathobiology, VP Government Relations, Research Ethics Office, Rotman School of Management, Trinity College Archives, and the UTSC Principal and Registrar's Office.

Garron Wells met with staff of central Human Resources concerning the management and disposition of SESU records (USWA job evaluation) in January 2008. Following this meeting, a subsequent meeting was held with Mary Ann Ross and staff of Office of Labour Relations regarding the management and disposition of that department's records. Loryl and Garron also met with staff of the Vice President Academic to discuss their records management concerns.

In the summer of 2008 both Garron and Loryl met with Real Estate Operations staff to discuss plans for that office's move to quarters at 255 McCall Street. The focus of this meeting centred on plans to accelerate the disposal of inactive records held by individual employees in their offices simply because there would not be enough room in the new quarters for the storage of large quantities of inactive records. The department had hired a consultant to assist them in developing plans for their "Purge Day". Archives staff recommended the review of existing records schedules to ensure the accurate disposal of inactive general administrative records, and to work

towards preparing records retention schedules for unique operational records. Materials determined to have long term value would be transferred to the Archives. As a result of this discussion, a large series of records containing specifications for many building projects was identified for transfer to the Archives, and summer Archives staff was trained to inventory and prepare these records for transfer by the end of the summer. The department did not submit a request for the development of records schedules pertaining to these or other operational records.

3.3 Records Schedules

The Archives continues to recommend to offices the development of filing systems and records retention schedules for their current and semi-active administrative records. Over the past 2 years, Loryl MacDonald worked with such offices as Procurement Services in developing a file plan for their electronic records. In January 2008, Loryl worked with staff at the Innovations Group (TIG), under the Office of the Vice President, Research and Association Provost in developing seven schedules for their office's records. Revised and new schedules were also developed for Governing Council's new Judicial Affairs Office which took over responsibility for university tribunal and other quasi-judicial activities.

4. ARRANGEMENT AND DESCRIPTION

4.1 University Records and Private Records (Tables 2a and 2b)

4.1.1 A Accessions (University Records)

Existing policies and practices require that, wherever possible, university offices are required to prepare a listing of files to be transferred to the Archives for permanent retention. This arrangement has been in place for a number of years, and has, since 2006, become even more important with the application of *Freedom of Information and Protection of Privacy Act (FIPPA)*. Of the 45 transfers received during the two years under review, 75% of offices were in compliance with this arrangement. Staff archivists modify the file lists to comply with our departmental practices. In some cases, two versions of a finding aid must be produced in order to protect the privacy of individuals in compliance with provincial legislation: a public version reflecting the removal of personal identifiers and a restricted version containing all personal identifiers for internal use only. In total, 33 finding aids were completed resulting in an additional 350 pages of description at the file level

As mentioned above, a small percentage of the offices either were unable or unwilling to produce a file listing. Certain types of media such as photographs, film, video and architectural drawings are examples of the type of records where offices rarely submit the necessary listing. As a result, Archives staff devoted considerable time in compiling original listings, often at the item level. Finding aids produced for special media are discussed in more detail in Section 4.2 below.

Finding aids for textual records received from Faculty of Arts and Science (A2007-0013 & A2008-0018; 4.0 metres), Office of Convocation (A2008-0006 & A2009-004 & A2009-0005; .21 metres), Real Estate Operations (A2008-0009; 50 metres), and Earth Sciences Library (A2008-0008; .39 metres) were produced resulting in 75 pages of description.

Backlog work

Considerable quantity of A accessions of university records require processing in order to make them available to researchers and to ensure compliance with privacy legislation. During the past two years, Lagring Ulanday under took much of this work. Among the projects was the reclassification of records deemed to be outside the jurisdiction of *FIPPA*. Two fonds were undertaken in 2008-2009: the University of Toronto Athletic Association (UTAA) records and the Women's Athletic Association (WTAA) records. For UTAA, 6 ephemera accessions (A1000s) and two A major accessions (A1979-0019 and A1984-0033) were reviewed, reappraised and where warranted, reclassified. The two major A Accessions were reclassified, necessitating the re-labelling of boxes, the editing of existing finding aids and the updating of the accession records database. The reappraisal of the ephemera material resulted in the majority of material being destroyed as duplicates and the adding of a couple of

items to existing Serials materials. Similar work was undertaken for the WTAA materials. In total, approximately 9.0 metres of records were reclassified. The experience of this process will be useful in reappraising the records of other university related organizations deemed to be outside the jurisdiction of FIPPA. However, such work is labour intensive and will be undertaken only as time permits.

In addition to this work, Lagring also completed finding aids for eight A Accessions, adding a further 59 pages of description. These included, among others, A1978-0008 records of the Faculty of Applied Science and Engineering (48 boxes; 6.18 metres). Compliance with FIPPA also necessitated the review of more biographical clippings files in the five boxes comprising A1975-0026 and A1978-0003. Lagring completed this work in the winter of 2008, thus making these records quickly open to researchers by removing records containing personal information.

4.1.2 B Accessions (Private Records)

The acquisition of gifts-in-kind from private donors necessitates the production of original finding aids by Archives staff in order to meet requirements for the issuing of tax receipts for the fair market value of such gifts. Indeed virtually all arrangement and description processing work resulting in series and fonds level finding aids is confined to new acquisitions for a particular year. The sheer volume of these gifts over the past years occupies staff time so completely that description of backlog private records is only undertaken if funding is received from an external source.

During the past two years in particular, the bulk of the processing of new private records gifts-in-kind was undertaken by Marnee Gamble and Harold Averill⁴, with Garron Wells processing a smaller percentage as time permits. During 2007-2009, arrangement and description of 19 gifts (received between 2006 and 2008) was undertaken, producing a total of 217 pages of new or revised finding aids. Of these 80% were fonds level finding aids.

The volume of material received from retiring faculty and staff as discussed in Section 2.3 above, combined with more complex rules from Revenue Canada and, in particular, the Canadian Cultural Property Export Review Board, means that the time line for donors receiving their tax receipts is lengthening. Increasingly, this means that a donor of a large quantity of personal records may wait often more than a year and occasionally even longer before monetary evaluation can be undertaken and a tax receipt issued. At this writing, a number of 2008 gifts, and several from 2007 are awaiting processing for income tax purposes.

4.1.3 Online access to accessions and fonds

In spring 2009, a total of 44 accession records for acquisitions of A and B accessions received in 2007 and 2008 were dumped into our public Accessions Database accessible from our web site. In addition 16 finding aids totalling 279 pages for B Accessions and A Accessions were published online in PDF.

With the University Archivist on research leave during 2008, no fonds level descriptions were added to the web site in 2007-2008. On return from leave in January 2009, Garron Wells wrote 15 fonds level descriptions for private records. Publication of these pages was postponed as the Library prepared to move departmental web sites to upgraded Plone 3 software. These will be published later in the spring when the Archives web site is moved to the new platform.

4.2 Special Media

4.2.1 Graphic Records

Marnee Gamble supervised the listing for the Zoology wall charts (A2007-0019) as well as 30,000 photographs from the Office of the President (A2008-0004). For accession A2007-0019, staff in the former Department of Zoology had prepared a spreadsheet listing the charts and also provided the original card index on which it was based. SLA Meredith White was assigned the task of checking the collection contents with this list to verify receipt. As a result, considerable staff time was saved since no extensive data entry had to be undertaken. The resulting finding aid at the item level comprises 23 pages, with an appendix of missing charts. In contrast, accession A2008-0004 consisting of over 30,000 photographs arrived with no listing. However, arrangement was, with the exception of 4 boxes, chronological within some 90 binders. SLA Karen Emily Suurtamm spent most of the summer of 2008 compiling a file level list in which groups of photographs were described. Each file level entry in the 18 page finding aid includes a brief description highlighting the individuals and/or event documented. In September 2008, the Archives facilitated the scanning of about 10% of these images from the Office of the President by the Division of University Advancement. Unfortunately, many of the scanned images were lost when the hard drive that stored the data was accidentally dropped. Marnee was able to retrieve about half of the scanned images stored on the Digital Studios computer.

Due to the large volume of acquisitions in this reporting period, the graphic database was not updated with the 2007-2008 records. However, 37 accessions from 1965 that had never been previously described in the Graphic database were copied from the Accessions database. These were often one item accessions that had been left out of the original Graphics Guide.

4.2.2 Image Bank Database - Web version

Ninety one records with accompanying images were added to the on-line image bank in November 2007. At the end of 2008-2009, 160 images had been described and are in need of jpg copies before they can be mounted on the online Imagebank. Space on the P drive where the master scans are stored has become a problem and this issue will need to be addressed in the 2009-2010 year. This has delayed the mounting of many of the 160 images that are described.

4.2.3 Sound and Moving Images Database

A request for access to the original Northrop Fry lectures by the Fry Society at Victoria College resulted in the digitization of approximately 400 3/4" Umatic tapes by the Information Commons Media Productions unit during the summer of 2008. These tapes were in A1996-0008 and were part of the Bible and Literature Series produced by the Media Centre in the 1980s.

As a result of discussions with the Chief Librarian around issues on tape obsolescence and the need to digitize many other titles in A1996-0008, Marnee Gamble prepared a report on how to proceed. Entitled *Preservation Strategy: Media Centre Videotape Collection A1996-0008*, the report outlines a strategy on re-mastering the tapes and once digitized, how these masters could be managed over the long term. This report was submitted to the Chief Librarian in June 2008.

Thirty-five descriptive records were added to the in-house Sound and Moving Image Title Database. The database was used to describe film, video and sound recordings found in three accessions: A2007-0018, New College; B2007-0007 Patterson Hume; and B2007-0018, Richard Lee.

The acquisition of 130 boxes of video from Instructional Media Services came with a listing of the tapes in an Excel spreadsheet. Marnee Gamble designed a database to capture this data and supervised SLA, Karen Emily Suurtamm, in inputting some 3000 Betacam and VHS tapes as well as over 200 reels of sound recordings. This database gives item level control of the collection and allowed the Archives to transfer the majority of these tapes to off site storage. Plans to enter the remaining 1" open reel tapes are underway for 2009-2010.

4.2.4 Architectural records: Architectural Records Database

During 2007 Garron Wells completed the arrangement and description of B1995-0055, Mathers and Haldenby Architects fonds. A total of 617 drawings were described at the item level during 2006 and 2007, and the resulting data added to the Architecture Database. In addition, data for 245 architectural drawings from A2007-0006 Office of Capital Projects were added to the Architecture database. For each of these accessions, a paper based report at the item level was generated which provided researchers with building by building listing of all plans. The database itself remains an internal resource for staff to respond to enquiries from academic and administrative researchers.

Some work was undertaken to add approximately 118 entries from the original *Guide to Architectural records* to the database but additional work will be required since only minimal data was recorded in the original *Guide*. When resources are found to undertake such a project, the additional data from the *Guide* will make the database a worthwhile online resource for the research community. For further information on work related to the storage of architectural drawings please see Section 6 Facilities.

4.3 Theses and Print Room materials

4.3.1 Graduate Theses – online records

During this period, data for graduate Theses held by the University Archives continued to be updated and revised in SIRSI for electronic retrieval of records in the University of Toronto online catalogue (UTCAT). This work, supervised by Barbara Edwards - Reference Specialist, was done with the assistance of the University Archives Student Library Assistants: Meredith White, Kelly Bishop, Karen Emily Suurtamm, Emily Monk-Leeson and Rachael Hazlett. In 2007 – 2008 Barbara completed data input for 143 Masters Theses with unique alphanumeric call numbers and designated Archives location. Similarly, in 2008 – 2009, 211 data entries for Masters Theses were completed, totalling an additional 353 Masters Theses records held by the University Archives with precise location and call number in UTCAT.

University Archives SLA staff completed a total of 1853 data entries for electronic PhD Theses records during 2007 – 2008. These were dissertations largely for the 1940s to 1960s. During 2008 – 2009, entries for 5716 PhD Theses records were completed. These dissertations comprised the years 1934 to 1940, 1963 to 1977, 1985 to 1986. This represents a total of 7569 dissertations in the University Archives with electronic records in UTCAT.

Overall, with these additional 7922 entries to online graduate records, it means that end-users can retrieve precise results showing Archives location and call number. Barbara continues to represent the Archives as a member of the Library's Theses Committee.

4.3.2 Monographs

The Print Room material, largely consisting of Monographs and Periodicals, continues to be maintained under Barbara's supervision. For this biennial reporting period, Barbara processed 190 (3.6m) books (M-accessions) and entered data for 102 records in SIRSI workflows for online access in UTCAT. She assigned call numbers, derived from the LC classification system, and created records of items for the pamphlet collection that are represented by UTARMS consecutive call numbers.

4.3.3 Periodicals

During reporting period Barbara created 75 new record titles for Periodicals (P-accessions) in the Archives Inhouse Serials DBText database. With the assistance of SLAs Meredith White, Kelly Bishop, and Emily Monk-Leeson 136 records were modified by entering holdings for issues of new and current newspapers and other serials. An overall total of 740 items (8.16m) were processed and 629 described (5.21m).

5.1 Reference and Research Services (Tables 3a and 3b and Figures 1-3)

Public service activities relating to reading room operation and responses to inquiries continued at a similar rate to previous years. Daily users increased by about 16% in 2008-2009 over 2007-2008 levels. This may in part be the result of two major history projects in progress: History of the Faculty of Arts and Science (launched in 2008) and History of the Faculty of Medicine (launched in 2009). The former project involves two researchers and the latter project has had up to three researchers. All researchers are working under the terms of research agreements since they are relying heavily on University records (A Accessions) subject to review under the *Freedom of information and protection of privacy act (FIPPA)*. These two projects have made heavy demands on photocopying services and our student assistants have been working at maximum levels to keep these and other requests up-to-date. As a result the number of pages copied in 2007-2008 of 13, 571 rose to 15, 952 in 2008-2009.

Phone and email inquiries (the main source of all written inquiries) totalled 756 for the past two years with 389 phone calls and 4,140 in person inquiries.

Over the past two years Harold Averill has made five revisions to and added 10 pages of entries to his online bibliography of publications based on sources in the University of Toronto Archives since its founding in 1965. This bibliography, begun in 1994, now comprises 45 pages of references to books, articles and theses, as well as plays, movies, TV broadcasts and other formats such as websites.

Several television and film productions have been supported by both staff and materials in the University Archives. They included a documentary on Wilfrid G. Bigelow by Les Productions Rivard inc. and a documentary on the COTC entitled *No Country for Young Men* produced by Stornoway Productions for the Breakout Educational Network. The latter film revisits the memories of Canada's lost tradition of university military training when citizenship, leadership and service were part of a university education. Photographs documenting World War I also assisted in the visual research for the Canadian feature film *Passchendaele* and the records of

Donald Coxeter were used extensively for the TVO documentary on the famous mathematician entitled *The Man Who Saved Geometry* which is scheduled to air in the fall of 2009

The special media holdings, especially the graphic collection, have also supported many displays and departmental histories in the past two years. Some of the offices that relied on visuals to support their endeavours are: Faculty of Physical Education and Health (Wall of Fame); University of Toronto Library (WWI display); Ontario Institute for the Studies in Education (history of the Faculty of Education and University of Toronto Schools); Division of Advancement (restoration of Convocation Hall), UofT Magazine, Soldier's Tower Committee (display), Department of Physiotherapy (departmental history), Faculty of Forestry (faculty history), Facilities and Services (phone book cover), and Cities Centre (décor).

5.2 Informal Access Reviews and Research Agreements in compliance with *FIPPA*. *Informal Access Reviews*

Informal access reviews involve the reading of all documents in files subject to review under FIPPA. A detailed process is in place whereby

- researchers provide list of records (Accession no., box no. and/ or file no) on the Informal Access
 Review Request form
- Archives staff reviews each page for any sensitive personal information.
- The record, file or box is determined to be either Open, or Restricted in part or Restricted in whole
- Archives staff segregate if possible any sensitive records from a file or box, filing these in another box designated as 'restricted'
- Archives staff revises the finding aid, if one exists.

Most researchers opted for this approach.

No of researchers making requests: 35 researchers

No. of items (i.e. folder or box) reviewed: 528

No. of hours @ 30 minutes per item: 264 hours (or 35 working days).

The bulk of these reviews during calendar year 2008 were undertaken by Loryl MacDonald since the University Archivist was on research leave. In 2007-2008 we reviewed nearly double the number of items than in 2008-2009 (190 items). This drop in volume over the last year may be as a result of the fact that more research agreements were issued in 2008-2009, thus alleviating the responsibility of staff to review the records, a process that can be time consuming and result in excessive delays for researcher access.

Research agreements

Research agreements may be issued to researchers under Regulation 460 (10) (1) of FIPPA. To protect personal privacy researchers must agree not to use any information on an identifiable individual without the express

written permission of the University Archives. The process involves a personal interview, the compilation of a list of relevant accessions by the researcher, and the preparation of a research agreement document with a specified time limit to conduct the research.

No. of research agreements issued:

2007-2008 = 13

2008-2009 = 20

As mentioned above we issued nearly double the number of research agreements.

FIPPA Formal Requests

The Archives participated in two formal inquiries under the legislation during these two years, all the result of denial of access by the Archives to records of an identifiable individual who had been dead for less than 30 years. In each case, we turned over copies of the records in question to the FIPPA office staff for final decision on access.

5.3 Tours

Staff of the Archives conducted tours for 88 people in 14 different groups over the past two years. They included groups from such faculties as the Faculty of Information and departments like Research Ethics Office. External visitors from Ryerson University, Queen's University Archives and the National Archives of Korea were also given tours over this period.

UNIVERSITY ARCHIVES ACCESSIONS USE



UNIVERSITY ARCHIVES MONTHLY USERS




6. FACILITIES

6.1 Storage

The Archives currently sends records to two off site facilities where a total of nearly 7,000 boxes (or approximately 7700 cubic feet) are stored. As of April 30, 2009 this volume represents approximately 25% of our total holdings. Details relating to these and our onsite storage facilities are provided below.

6.1.1 UTLD (University of Toronto Libraries at Downsview)

After consultations with the Library, the Archives started shipping materials to this off site facility in the summer of 2007. The first materials to go were new acquisitions of university records accessions and low use materials in our B1 storage area. UTLD is able to accommodate our record storage boxes, as well as smaller archival storage boxes. UTARMS developed its own database to control the inventory of materials at this storage facility. Working in cooperation with Lari Langford, head of Access and her staff at UTLD, Loryl Macdonald developed procedures for bar coding, data entry, shipping and receiving. As of April 30, 2009 we have sent 1757 boxes (or approximately 1933 cu. Ft) of records to UTLD. Most of those sent are university records (A Accessions). However, to free up space for use by Rare Books Department (RBD) in our B1 storage area, we entered into a cooperative project to pack and ship the majority of records (over 80%) of the Vincent Massey Personal Records (B1987-0082) in the fall of 2007. In addition SLA Kelly Bishop packed up theses that were also stored in this area. As a result 312 linear feet of shelving was made available for use by RBD in the pine compact shelving area. The process set up for retrieval and returns to UTLD has worked very smoothly over the past year and a half with turn around times of 24 hours.

A further 84 shelving feet of theses were removed from the 4th floor to make way for racking for the overflow of Wall Charts received from Zoology. These were also sent off site in the winter of 2008.

6.1.2 Commercial Storage

We continue to retrieve materials from commercial storage at a rate of approximately 3 boxes per month. Total cost of storage was about \$21,000 for 2007-2008 and \$21,600 for 2008-2009. Even though we have ceased to

send additional records to this storage facility costs continue to rise as retrieval and storage service costs are adjusted annually. We have made submissions to the Library's Finance office regarding the cost to move materials from the commercial off site vendor to UTLD, but additional funding is required to undertake such a project.

6.1.3 on site storage

Architectural plans storage system

Storage space in flat drawers for oversized architectural drawings is a luxury few institutions can afford. Since the Archives had undertaken the processing of the large Mathers & Haldenby fonds during this reporting period, it was essential that we devise a cost effective method of storing these valuable records. Using a system developed by an American library, we acquired card board tubes in two sizes: smaller size tube used as support for rolled plans which was then inserted in to a larger card board tube. The larger tube became in essence the 'shelf' for a group of plans. Each end of the larger tube was closed with a plastic disc to keep dust and dirt out. To accommodate these tubes, we converted a portion of the shelving system in B1 by removing flat shelves and then stacking the larger tubes on top of each other and wedged securely between the two stationary supports.

With the assistance of Linda Joy, conservator in the Rare Book Department, acid free paper was cut into two sizes. A smaller size sheet was pasted to the narrow tube to provide an acid free protective barrier. A larger sheet of acid free paper was cut to wrap around the plans which were then tied with cotton tape. This package was then labelled with the full accession no. and roll (i.e. "shelf" number), and inserted into the larger tube 'shelf'. This system has allowed for the storage of approximately 1700 drawings currently with room for expansion.

Modifications to 3rd and 4th floor storage areas

With the transfer of the 700 wall charts from the former Department of Zoology, modifications to the storage facilities on both 3rd and 4th floors had to be undertaken in the fall of 2007. Funding from the Library operating budget was received to install a hanging system for the wall charts. Marnee Gamble spent several weeks retrofitting 3rd floor oversize shelves in the photographic area (range 47), consolidating all the materials on eight oversize bays on Range 47 as well as on end bays on ranges 1 and 46. Twelve bays in total on the fourth floor were emptied of theses and fitted with rods on which to hang the drawings. The approximately 84 cubic feet of theses were moved to UTLD.

7. ADMINISTRATION

7.1 Freedom of Information and Protection of Privacy Act (FIPPA)

At the request of the University's FIPPA office in 2007, the Archives developed and implemented a Directory of Personal Information Banks database and related web pages. In addition, web pages containing a List of Administrative Offices with associated links to departmental web sites was completed as well.

7.2 Staffing

Departmental staff complement remained stable throughout this reporting period. Part-time casual student assistants change on a regular basis and during this period we were ably assisted by the following Student Library Assistants: Emily Monks-Leeson, Karen Emily Suurtamm, Sarah Green, Rachel Hazlett, and Meredith White.

7.3 Closing, August 2007 and August 2008

Over the past two years, UTARMS has continued to implement a two-week closing period at the end of August. During these closing periods, staff have undertaken projects that could not be undertaken with the reading room at full public operation. Projects chosen include stack re-arrangement and maintenance, general housekeeping activities, shelf reading and large off-site transfer projects. Projects during these two years included:

Architectural plans storage system

As discussed in Section 6, 900 items were shelved during August 2007 closing. Loryl MacDonald completed the shelving of 16 additional drawings in August 2008, as well as tagging and encapsulating other plans stored on the 4th floor.

Shelf reading of onsite stack areas

In 2007 staff conducted a shelf read of all shelves on the 3rd floor storage area. This took most of the two weeks of our closing period. It resulted in considerable time tracking down misplaced items. In 2008, Lagring Ulanday completed a shelf read of 4th floor print room area. In both years, work was also undertaken to reconcile missing and incorrectly shelved items with Marnee Gamble revising the shelf list database as necessary.

Housekeeping

During both these years, staff made it a point to clean up work and storage areas, as well as account for items that may have not been appraised or identified in previous years. In 2008 for example, Loryl and Marnee re-arranged and listed the works of art stored in the closet on the 3rd floor. The list was then checked against existing accession records to complete the documentation. Harold reboxed and moved past exhibition records from under the display cabinets in the Reading Room to compact shelving on B1 and compiled an inventory.

7.4 Presentations

In the fall of 2007, Garron made a presentation to Senior Library Staff on developments in the University Archives over the past year. This included an update on FIPPA work as well as the new architectural plans storage area on the B1 level. At the invitation of RALUT chair Joan Winearls, Garron Wells made a presentation to retired librarians and faculty on donations of personal papers to the University Archives on March 3 2008. Loryl MacDonald made a presentation relating to the University's records management programme for TKF.07 University conference on managing electronic records attended by University employees. At the request of the Faculty of Information Loryl made presentations to graduate students in FIS 1330 Archives Issues and Concepts (50 students), and FIS 1332 Archives Programs and Services (50 students).

7.5 Professional and Other Activities

Garron Wells attended International Council on Archives/Section on University and Research Institutions (ICA/SUV) conference in Edinburgh August 13-16, 2007. She was on research leave during calendar year 2008 for her project on "The place of archives in Canadian culture". She returned to full time duties in January 2009. Marnee Gamble attended a two day conference - *The Future of Monetary Archival Appraisal in Canada*. It was held in Ottawa on October 22-23 2007 and was sponsored by the National Archives Appraisal Board.

Marnee Gamble also attended the Annual Conference of the Association of Moving Image Archivist from November 12-15, 2008 in Savannah Georgia. As part of the conference she attended two, one day workshops both related to digital preservation of video collections.

Harold Averill continues to volunteer in various capacities at the Canadian Lesbian and Gay Archives.

Loryl MacDonald was the Association of Canadian Archivists (ACA) Director Without Portfolio and Chair of the ACA Ad Hoc Review and Renew Committee until December 2007. She then served as ACA Vice President and as Chair of the Governance Committee from January to December 2008. In these various capacities, she attended the ACA annual conference in Kingston, Ontario in 2007 and in Fredericton, New Brunswick in 2008. Loryl was also an archival representative on Library and Archives Canada Services Advisory Board (LACSAB). As well, Loryl has begun guest co-editing with Jean Dryden, a special issue of the ACA's academic journal, *Archivaria* #69 (Spring 2010), which will be devoted to "Archives and the Law". During the summer of 2008, Loryl taught the course FIS 2175 *Managing Organizational Records* at the Faculty of Information. A weekly 3 hour seminar, it introduces students to the principles, conceptual issues and practical problems of managing current organizational records, both paper-based and electronic. She has since renewed to teach in the summer of 2009.

Lagring Ulanday resigned her position as archivist with the Toronto Chapter of ARMA after securing the transfer of its archives to the City of Toronto Archives and its publications to Inforum at the Faculty of Information. Despite her resignation, Lagring continued to receive requests for ARMA related assistance which she referred to her successor, along with selective electronic files generated during her term as archivist.

Barbara Edwards commenced graduate degree studies at the Faculty of Information, University of Toronto with Library Science as intended area of focus.
